#### Call for Nominations to the AEF Board of Directors

AEF is seeking candidates to volunteer and serve on its Board of Directors to support and advance the vision, mission, and strategic plan of the organization. The AEF Board reflects a wide range of experience, skills, knowledge and abilities. We value diversity in our membership and on our board from all areas of Alberta you do not need to be a horse owner or equestrian to be a board member. You do, however, need to have a passion for equines and their people. Individuals from a range of backgrounds and professional sectors are considered valuable to the Board.

Nominations open December 10, 2024.

Deadline to submit nomination form is January 24, 2025.

# Requirements of the AEF Board of Directors (elected officers of the AEF):

- Directors shall fulfill all requirements of the Alberta Societies Act and shall be permanent residents of Alberta and of legal age (18 years or older).
- Directors shall commit themselves to ethical, businesslike and lawful conduct, including proper use of authority and decorum when acting as Board members.
- Directors must be able to represent an unconflicted loyalty to the interests of the AEF members. This
  accountability supersedes any conflicting loyalty such as to advocacy or other interest groups.
- Directors are recruited based upon their demonstrated ability to contribute significantly to the leadership of AEF and to fulfill fiduciary responsibilities.



#### Terms of service:

The AEF Board consists of up to 12 Volunteer Directors and 3 Presidents (Current, Elect, Past). All Directors serve a three-year term to a maximum of two consecutive terms (6 years) and must stand for election from term to term.

#### Directors are involved in:

- Ongoing evaluation of the organization's mission, vision and values;
- Monitoring the organization's progress towards achieving its mission and strategic planning;
- Community and stakeholder outreach;
- Continued evaluation of the organization to best serve the membership;
- Financial oversight (due diligence) and fundraising;
- Board self-maintenance, including recruitment and orientation of new directors.

#### Directors must:

- Attend a minimum of 60% of scheduled board meetings (6 to 8 meetings per year). Tentative meeting schedule for 2025:
  - o March 6 AGM via Zoom
  - o April 26 in person
  - o June 19 via Zoom
  - o Sept. 18 via Zoom
  - o Oct (TBD) in person
  - o Nov. 19 via Zoom
- Participate on standing and ad hoc committees as needed;
- Participate and network at internal and external events, fundraising events, related meetings, member and non-member events, and other activities as necessary, and report on those activities;
- Be readily accessible and responsive to email and voicemail, and web-based communication;
- Positively support the aims and objectives of the organization;
- Abide by the AEF Bylaws, Code of Ethics, and Governance Manual Policies.

# Core competencies that will be reflected in the Board of Directors, as a whole, are:

- Business acumen;
- Positive communication and community relations;
- Financial management experience;
- Demonstrated understanding of legal and human resource principles and frameworks;
- Governance experience and knowledge;
- Strategic planning experience.



#### Time commitment

Board members must set aside time to attend meetings (6 to 8 meetings per year, majority via Zoom conference call), attend fundraising initiatives, attend member and non-member events and meetings, and work with committees as determined by the board to support AEF activities.

### Eligibility, application, and selection

Note: nominations are NOT accepted at the AEF Annual General Meeting (AGM).

Note: elected nominees must attend the AEF AGM via Zoom on March 6, 2025, at 6:30 pm.

- 1. To be eligible to stand for election, an individual must:
  - a. Be 18 years of age or older;
  - b. Be a member of the AEF when the nomination is submitted
  - c. Be nominated by an AEF member (and accept) or self-nominate by completing and submitting the nomination form which includes a brief biography and photo.
- 2. Nominations can be made at any time, up to Friday, January 24, 2025, at midnight.
- 3. Nomination forms must be complete and be submitted by email with a jpeg photo (min 150kb).
- 4. Incomplete nomination forms will not be accepted.
- The AEF Nomination Committee will review nominations and request and conduct interviews with selected nominees.
- 6. The Nomination Committee will recommend to the board a slate of candidates it believes are best suited to the role based on the nomination form and criteria.
- 7. AEF voting members will vote for candidates electronically prior to the AGM.
