Financial Awards

The annual bursary amount of up to \$500.00 is available.

Application Criteria

- 1. Are a current AEF member in good standing;
- 2. Be participating, wanting to participate, or purchasing an ASTM/SEI Certified Helmet for Western related equestrian activities;
- 3. A resident of Alberta:
- 4. Are between the ages of 13 and 17;
- 5. A parent or legal guardian must sign the application form.

This bursary is intended to support learning outcomes and/or safe riding - it may be used towards supplementing camp/workshop fees, riding lesson fees, registration in recreational competitions, or the purchase of an ASTM/SEI Certified Helmet for horseback riding. Receipts are mandatory.

The application package must be completed in full and received by **September 30** of each year. Late or incomplete applications will not be considered. Successful applicants will be notified by **October 31** of each year. Successful applicants will be selected on the basis of information contained in their application form and that of which meets the criteria outlined.

Important: AEF does not return application materials. Personal information is considered private and confidential. Successful applicants will be asked to provide additional information or photographs for use in AEF marketing, both electronic and hard copy. AEF reserves the right to withdraw or modify all or part of this program and application process at any time.
