Casinos are a vital way for the AEF to raise funds that help to operate and deliver strong and viable member programs and services to the Alberta equine community. You are invited to volunteer and we hope you will consider! Here is what you need to know...

- ✓ Volunteering at a casino is easy and FUN!
- ✓ You do not need experience.
- ✓ All volunteers must be over the age of 18 and not have a criminal record.
- ✓ Food is provided to volunteers FREE of charge and there are five restaurants at this facility!
- ✓ Your hotel and transportation is covered (an additional night of accommodation and breakfast is included for volunteers travelling at least 100 kms from their residence).
- ✓ AEF requires a minimum of 25 volunteers to run this casino successfully.
- ✓ Volunteers do NOT NEED to be AEF members; bring your friends and family to help!
- ✓ Volunteers are accepted on a first come, first serve basis for available shifts. If you volunteer for both days, you must work in the same position, e.g., you cannot work as a cashier one day and chip runner the next.
- ✓ The money you are raising is going to support a great cause, so ENJOY!

No individual is eligible to work in a casino if charged or convicted, within the last five years, of a criminal offence related to narcotics or act of dishonesty, including but not limited to offences involving fraud, currency, or gaming and betting or those against the rights of property (such as theft, robbery, forgery), or firearms and offensive weapons, or an indictable offence for an act of violence against a person. If five years after conviction an individual is still under sentence for such an offence, approval shall not be given under this application until the completion of sentence. Alberta Gaming and Liquor Commission (AGLC) may contact police for relevant information about the applicant. If an individual has received a pardon under provisions of the Criminal Record Act, this policy will not apply.

AGREEMENT AND SIGNATURE

By submitting this application, I affirm that the facts set forth in it are true and complete. I understand that if I am accepted as a volunteer, any false statements, omissions, or other misrepresentations made by me on this application may disqualify me from working at a casino. I hereby consent to and authorize the AGLC to undertake a criminal record check, with any police agenda, to determine my eligibility to be involved in gaming facilities, in accordance with AGLC policies. An application may also be required to obtain and provide a criminal record check from a police agency.
